The purpose of the Superkarts! USA Licensing Program is to provide a standardized ladder of driver development within the organization. The following document details each license level, its requirements and the classes that are eligible to the holder of each respective license.

A

A LICENSE

The A License is reserved for SKUSA's most accomplished drivers. This license is required for any driver wishing to compete in the S1 category. Competitors will be required to complete an application form that will include an area where the driver will present results, performance highlights and a career overview, which the SKUSA staff will use to determine license eligibility. Only drivers with an A license are permitted in S1. KZ drivers require an A or B license.

Applicable Classes: S1 and KZ

B

B LICENSE

The B License is the primary license for all experienced adult drivers in Superkarts! USA. To be eligible for a B license, one must have at least two years of prior experience in the sport. Competitors new to SKUSA must complete an application form detailing past experience to be considered for a B license instead of a C license.

Applicable Classes: S2, S4 / S4SM, X30 Senior, X30 Master, and KZ

C

C LICENSE

The C license is presented to anyone new to karting within the Superkarts! USA community. For drivers who are new to shifterkart competition, this license will make them eligible for the S3 (Novice Stock Moto) category. Should they wish to advance to the S2 (Semi-pro Stock Moto) or S4 (Master Stock Moto) classes, they will need to show proficiency on the racetrack and then apply for an upgrade to a B license.

Applicable Classes: Drivers in S3, S4 / S4SM, X30 Senior, and X30 Master

D

D LICENSE

All Junior drivers will receive a D License when joining SKUSA. Any Junior driver wishing to graduate into a Senior class (Stock Moto or X30 Senior) will automatically qualify for a C License, which will make them eligible for S3 (Novice Stock Moto) or X30 Senior. Should a driver wish to graduate into S2, they will need to apply for a B License.

Applicable Classes: S5, X30 Junior, Mini Swift, and Micro Swift

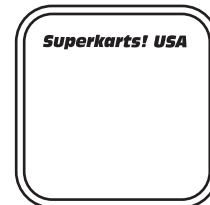

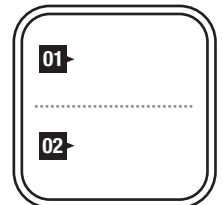

All membership cards and credentials are the property of the issuer, SKUSA, and are issued to the applicant upon completion of application and acceptance of SKUSA. The bearer of said membership or credentials accepts same under these terms and conditions and, by his/her signature on this application, states that all information is true and accurate. Authorized bearer of membership or credentials understands that participation in any SKUSA event, or part thereof, is contingent upon presentation of said membership or credentials. Inability to present membership card or credentials to SKUSA officials may disqualify customer from any event. All

customers are required to possess working knowledge of current year SKUSA rule book and ignorance thereof shall not be deemed justification for any act or condition contrary to said rule book. Conduct of any driver and/or driver's crew deemed unacceptable by SKUSA will result in a demand for surrender of license or credentials and disqualification from event. Unacceptable conduct includes, but is not limited to, personal acts or appearance not conducive to professional racing, rules infractions or drive style considered to place him or herself, and others, at risk. Issuance of all new Competition Licenses is considered, at the outset, provisional. Drivers with one or more years of SKUSA specific experience are excluded from provisional status unless otherwise specifically indicated. Waiving of provisional status for any new customer is at the sole discretion of SKUSA and/or its designated review group. Provisional licenses are insensitive to stated levels of previous experience.
